# F.E.W.A. AFFILIATE MEMBERSHIP AGREEMENT

**WHEREAS**, Affiliate Member and F.E.W.A. agree as follows:

**1. CONSIDERATION** - F.E.W.A. will provide the Allied Affiliate Member with all the Allied Affiliate Member Benefits described below in Section 2 of this Agreement.

**2. AFFILIATE MEMBERSHIP BENEFITS:** Affiliate Members are entitled to the following benefits:

- C.** The final determination of benefits to be provided under this Agreement shall be made solely and exclusively by FEWA but shall not be any less than as provided herein. FEWA may add features or content to the Allied Affiliate Member benefits from time to time without prior notice to the Allied Affiliate Member.

**4. ALLIED AFFILIATE MEMBERSHIP DUES:** None.

**5. TERMINATION OF MEMBERSHIP:** This Agreement shall remain in effect until either party gives written notice to the other party that the Agreement has been terminated.
